



FILMMAKERS' INDEPENDENT PRODUCTION EQUIPMENT SUBSIDY APPLICATION FORM

Application Guidelines:

- applications must be submitted on this form;
- applicants must meet with the Production Support Manager to discuss project requirements and the subsidy level requested *prior to application*;
- applications are on a single-project basis only and must clearly state the amount of subsidy requested from the MRC;

Terms and Conditions:

- the applicant must be an MRC member [\$45 per annum];
- a minimum of 3 [*three*] MRC members must be involved in the project, with at least one in an above the line role;
- the production itself should benefit the filmmaking community, individual filmmakers and crew as a whole. This funding is aimed at productions with artistic and/or cultural outcomes.
- production and post-production must be carried out in South Australia;
- standard MRC Hire & Conditions apply to all subsidised hires;
- all subsidised equipment hires must be paid in full prior to hire;
- the production subsidy does not include any form of credit;
- tape stock and other consumables and certain equipment items are not eligible for subsidy;
- all subsidised projects must acknowledge MRC assistance, in the form of an MRC logo or other, as determined by the Production Support Manager;
- subsidised hires are subject to availability and may be cancelled or postponed due to requested bookings by full-paying hirers. In such an event, subsidised hirers will be given 24 hours notice and the option to pay full rates in order to hold the booking;
- the MRC has the right to refuse any individual or organisation in bad financial standing or with outstanding debts against previous hires or activities where the MRC has billed the organisation.
- the MRC can withdraw support for any production at any time and without notice;
- commercial productions are assumed to have funding from private enterprise and will not be eligible for MRC production funding.
